Finances:

Started the year with \$4451.07 (at Last AGM) Ended this year with \$6961.87 (at this AGM)

Trips were not for profit and paid for by members. We are looking at how to spend this money to further the Player's, possibly a bigger production, More trips and workshops.

Charitable Incorporated Organisation:

With the constitution already written, we are now in a position to move forward on becoming a C10. We will be needing 3 or more Trustees and Lexii will be advertising in the next Holbeton news, On the Facebook page and on the website. Our closing date is 25th July when we will vote those members in.

As you may know the benefit of a C10 is that we can benefit from those grants and perks of a Charity without the stress of having to earn a specific amount per year. As well as not having to pay staff and enter into commercial contracts as a Charitable Organisation would. Another reason for choosing this format is that being incorporated doesn't leave our Trustees personally Liable in case of any issues.

There are two structures - Open and Closed - We chose Open.

Closed is a C10 that is entirely run by committee and Trustees with no wider membership. This would not work for our model.

Open is run by the Committee within Trustee ruling with a wider membership.



Other Items:

A worry that the Wild Will Productions will negatively impact the Holbeton Players with so many members being in the production.

It was suggested that we make a collaboration with Wild Will Productions as Rob made a generous donation last time, he clearly values the help. Another suggestion was that we put on more smaller productions so we do not have a reduction due to these bigger productions by Rob Hyland.

Lack of publicity effecting our own productions

We have appointed a publicity committee member, Mark Sims. However, it is important that events, rehearsals and auditions are fully communicated to all committee and Trustees to ensure the most amount of coverage and publicity is created for our productions.
